

## **WITHDRAWAL OF CONSENT NOTICE**

Orange Credit Pte Ltd is a company registered under the Laws of Singapore.

Orange Credit Pte Ltd (“OCPL” or, as appropriate in the context, “we”, “us” or “our”) respects the protection of your Personal Data and we at Orange Credit Pte Ltd value our relationship with you.

OCPL agrees that you have the right under the Personal Data Protection Act (2012) to withdraw consent to us using, disclosing and processing your Personal Data.

### **Withdrawing Your Consent**

You may withdraw your consent to OCPL using, disclosing and processing your Personal Data for a particular purpose(s) at any time.

The purposes for which OCPL uses, discloses and processes your Personal Data are set out in our Personal Data Policy.

Some purposes for which OCPL uses and shares your information are necessary to OCPL providing services to you (or, where applicable, to your employer or to your business).

Other purposes are optional to OCPL providing services to you. You may withdraw your consent to optional purposes without withdrawing consent for necessary purposes.

OCPL will respect your decision to withdraw consent. Should you choose to withdraw consent to OCPL using, disclosing and processing your Personal Data for purposes necessary to OCPL providing services to you, OCPL will respect your decision and will stop using, disclosing and processing your Personal Data.

However, please understand that your withdrawal of consent for purposes necessary to OCPL providing services to you may carry legal or practical consequences, which will continue to apply.

Once we receive your notice that you wish to withdraw consent, we will contact you within seven days to acknowledge receipt of your withdrawal notice and within 30 days to inform you of the likely consequences of your withdrawal of your consent to OCPL using and sharing your Personal Data.

OCPL will cease to use and share your Personal Data within 30 days after our acknowledgement of receipt of your withdrawal notice.

OCPL will also inform OCPL's agents and data intermediaries (organisations who process Personal Data for and on behalf of OCPL under agreement) to stop using and sharing your Personal Data.

If we require more information from you in order to respond to your request for withdrawal of consent, we will contact you at the contact address you have provided within 30 days after our acknowledgement of receipt of your withdrawal notice to obtain the necessary information from you.

Please understand that after your withdrawal of consent, OCPL will continue to retain your Personal Data for OCPL's business and legal purposes in accordance with applicable legislation, including the Personal Data Protection Act 2012.
